Sites on the edge of existing settlements (Rural/Entry Level Exception sites).






Conditional or unconditional contracts.


Option or promotion agreements (we will also take assignment of existing deal structures).





#### **Great Gonerby, Grantham, Lincolnshire** This 4.87 acre site was purchased in November 2019, once planning permission had been secured. Work started on site in August 2020 to build 46 mixed-tenure affordable dwellings.
